AUDIENCE PARTICIPATION -

<u>Dave Fingerlow 32 Seventh Avenue</u> – We have a lot of potholes in North Tonawanda. The streets are not getting paved correctly. When I worked for the DPW the Superintendent ignored my suggestions on how to pave the streets. The Superintendent is having the workers pave the streets all wrong. They are not cleaning them correctly before they pave them, nor are they building up the receivers the right way. The Superintendent also does not believe in hot patch, he just uses cold patch which does not work as well. Someone is going to get hurt. Don't blame the workers, they are just following orders. I think the Superintendent is just wasting taxpayer's money.

<u>Joseph Kissel 950 East Robinson Street</u> – What is a Commissioner of Deeds? The City of Lockport just bought a piece of equipment called a hotbox so they could do hot patch all year round. It is expensive but Lockport felt it was important.

Robert Kensek 337 Christiana Street – I agree with the gentleman that spoke early, the roads are not good in this City. No one takes pride in their work. I also disagree with the project to realign the intersection at Meadow and Payne. The problem is the drivers, not the signs or signals. Why are all these young people afraid of the current administration, they just want free handouts.

<u>Dennis O'Sullivan 192 Walter Drive</u> – When are the street lights going to be put in. It is dangerous and someone is going to get hit.

<u>Kristen O'Sullivan 192 Walter Drive</u> – You mention that it takes 80% of the street to be completed before National Grid puts street lights in, is it 80% of one side or the entire street. Do they just put lights on one side or both? How is the cleanup going on Donner Creek?
