Re: City of North Tonawanda / Lumber City Development Corporation commercial property agreement - 653 Oliver Street

Dear Honorable Body;

In 2014 the City and Lumber City Development Corporation (LCDC) entered into an agreement enabling LCDC to market and incentivize the sale and redevelopment of selected commercial properties owned by the City of North Tonawanda. The initial list of selected properties included 653 Oliver Street, 664 Oliver Street, and 301 Payne Avenue. The intent of this agreement was to identify properties in the tax foreclosure process which have suffered neglect and are currently detrimental to their surrounding neighborhood and promote responsible ownership and redevelopment of these properties in an attempt to stabilize and improve their respective neighborhoods.

The City and LCDC established a set of guidelines for prospective purchasers interested in these properties. The guidelines included submitting a proposed redevelopment and property reuse plan, including project cost estimates and financial capability, as well as requiring the potential purchaser be in current good standing with the City with regards to any other property owned within North Tonawanda.

LCDC has received a purchase offer and redevelopment plan for 653 Oliver Street from Mr. Matthew Bille. Mr. Bille has proposed to purchase the property for \$1,000 and invest an estimated \$90,000 in renovations and repairs. Mr. Bille intends to lease the two second floor apartments and maintain a commercial/retail use on the first floor and is currently searching for a potential tenant. Mr. Bille currently owns five properties in North Tonawanda and is current on all taxes and fees and has no outstanding code violations or complaints.

LCDC believes Mr. Bille's investment in 653 Oliver Street will have a positive impact on the neighborhood and will revitalize a vacant structure. LCDC would like to hereby recommend the City of North Tonawanda consider accepting Mr. Bille's purchase offer.

<u>Austin Tylec 815 Niagara Parkway</u> – The Oliver Street Merchants Association is having a cleanup day with Webster Street Merchants and Project Pride, we would like to know if we could get some chairs and tables from the City? So the same would go with supplies provided by the City like bags, gloves, and rakes. Could we just go to the department heads? If there is anything that could be done later in the week just contact one of the organizations.

<u>Cathy Kern 1248 Greenbrier Lane</u> – I have lived in Wurlitzer Park since 1968. We are constantly losing power. We use to have town hall meeting with all the parties involved. It is known that Wurlitzer Park is the home of no power. The power company said it will never be fixed, we are too poor. I need somebody to take the lead and get us some answers. I want the City to get behind us and find out the cause and the cure.

<u>Alan Mazzuchelli 1426 Doebler Drive</u> – Why do we have stop signs on Payne Avenue and Goundry and Payne Avenue and Tremont? There is no reason for them to be there. How

do we go about getting them removed? Does anyone know why the signals have been taken down and not been put back. I have been told they will never be put back.

Zachary Niemiec 384 Robinson Street – I would like to thank you all for approving me for Commission of Deeds tonight, but my question is since the School Board did vote down the credit is the City going to go back and negotiate with the School Board. I think both sides should go back to the table and negotiate.

Malcolm Needler 1109 Farnsworth Avenue – This is the first time I have ever been on this side of the lector. We need to have some common sense. It doesn't matter which hand you are taking money from it is the same money. I am of the understanding that the School District has pipes that go around the meters so they can fill their pools. You need to treat the School and any other person or business the same, and make sure these meter bypasses are capped off. My neighbors have to pay to fill their pools, the School District should also. After that if you want to renegotiate do it right.

<u>Dave Fingerlow 32 Seventh Avenue</u> – I would like to know if you have looked into changing Terrace Parking. The City had changed the law a while ago so no one can park on the Terrace unless you do not have curbs. But businesses park on the Terrace to load and unload trucks and people get special permits. I hope you do what is right for the public, not just half of the City. I would also like to comment on the DPW. Only the last 5 to 6 years things are not being done right at the DPW. The workers are being told to pave wrong. I am not blaming the guys.

Sonia Dusza 123 Miller Street – Number one, years ago the Department Heads were here, I would like to see that come back. Secondly, Kathy I was wondering if Wurlitzer Park is still having issues with power outages. I care about the whole City. Thirdly, I was reviewing the 1955 and 1974 sewer study. You should all read it, it will be your bible. The author said the City should adopt it. The fourth item, the Building Inspector chose a company to cut grass for violators. I hope the company he recommends does a good job. Lastly is the City addressing the reality of the illegal non-conforming use in our City? Is that being addressed? We need to address basic functioning in our City.
