On May 23, 2017, the City published a request for proposals (RFP) for firms capable of assisting the City with the creation and implementation of a Foreclosure Prevention Outreach Plan. This Plan is a deliverable item related to the Local Initiative Support coalition (LISC) Zombie Property Prevention grant awarded to the City in 2016. Proposals from interested firms were due to be received by the City on June 9, 2017.

The City received one proposal from Belmont Housing Resources for WNY (Belmont). Belmont is a non-profit housing agency which provides services including; housing counseling, financial education, property management, and housing program administration. Upon review of the proposal, Belmont demonstrated sufficient experience to meet the scope of services outlined in the RFP and successfully create and implement the Foreclosure Prevention **Outreach** services.

Belmont has proposed a fee of \$6,545.00 to provide the Foreclosure Prevention Outreach Plan. This fee will be covered out of LISC grant funds with no direct cost to the City.

### MEMORANDUM OF AGREEMENT BETWEEN THE NORTH TONAWANDA POLICE BENEVOLENT ASSOCIATION, INC. AND THE CITY OF NORTH TONAWANDA

#### Re: Single Channel Dispatch

This Memorandum of Agreement (MOA"), dated and effective as of the last date executed below (the "Effective Date"), is by and between THE NORTH TONAWANDA POLICE BENEVOLENT ASSOCIATION, INC., ("PBA") and THE CITY OF NORTH TONAWANDA ("City"). The PBA and the City are referred to jointly as the Parties.

WHEREAS, the terms and conditions of employment for PBA members are contained in a Collective Bargaining Agreement ("CBA") between the Parties dated December 31, 2015. covering the time period of January 1, 2016 through December 31, 2020; and,

**WHEREAS,** the PBA contends that the City's unilateral implementation of Niagara County's single-channel digital communications system and its transfer of the City's dispatch function to the Niagara County Sheriff's Office constitutes an improper labor practice and violates the statutory prohibition against intermunicipal agreements beyond a term of five years; and.

WHEREAS, there is a pending appeal of litigation in New York State Supreme Court, Niagara County, under the caption "North Tonawanda Police Benevolent Association v. Common Council of the City of North Tonawanda, Arthur G. Pappas, as Mayor of the City of North Tonawanda, County Legislature of the County of Niagara, Richard E. Updegrove. As County Manager of the County of Niagara, and James R. Voutour, as Sheriff of the Niagara County Sheriff's Office," under Index No. E159354/2016 ("Proceeding"), concerning the City's transfer of the dispatch function to Niagara County; and,

WHEREAS, there is an ongoing Impasse Mediation before the Public Employment Relations Board ("Mediation"), Case No. M2016-161, arising from the PBA's Declaration of Impasse in negotiations concerning the City's implementation of a single-channel dispatch system; and,

**WHEREAS,** the PBA and the City wish to settle this matter to avoid the uncertainty, expense and burden of moving forward in this Proceeding and Mediation; and WHEREAS, each party agrees that it has had a reasonable amount of time to consider this MOA;

#### NOW, THEREFORE, IT IS AGREED BY THE PARTIES AS FOLLOWS:

- 1. The City will take all necessary action to ensure that the Niagara County Sheriff's Office implements a dedicated channel with an assigned dispatcher to that channel per shift for the exclusive use of the North Tonawanda Police Department;
- 2. Section 7 of the parties' CBA will reflect that the PBA agrees to a one (1) percent reduction in annual base pay for all bargaining unit members effective July 1, 2017:

- 3. Section 7 of the parties' CBA will reflect that the PBA agrees to accept a one (1) percent increase in annual base pay effective January 1, 2018 for all bargaining unit members instead of the two (2) percent scheduled increase set forth in Section 7.11;
- 4. The City agrees to take all necessary action required to remove any legal authority including, but not limited to, the City Charter, city laws, rules, regulations and practices that requires bargaining unit members to maintain City residence during their employment with the City;
- 5. The City shall obtain and allow the PBA to review prior to executing any agreement or memorandum of understanding between the City and Niagara County and/or the Niagara County Sheriff's Office governing the terms and conditions of operations regarding the dedicated channel and the assigned dispatcher;
- 6. In the event that the City Fails to implement the dedicated channel and/ or the assigned dispatcher, or, after implementation, there are changes affecting the dedicated channel and/ or the assigned dispatcher the City shall reimburse the PBA bargaining unit members for the wage concessions set forth under numbers 2 and 3 above;
- 7. Should any provision of this MOA be declared or be determined by any court to be illegal or invalid, the validity of the remaining parts, terms or provisions shall not be affected thereby and said illegal or invalid part, term, or provision shall be deemed not to be a part of this MOA.
- 8. The terms and conditions contained in this MOA supersede all prior oral or written understandings between the parties and constitute the entire agreement between them concerning the subject matter of this agreement. The terms of this MOA cannot be changed or modified in any respect except in a validly executed writing signed by the parties.
- 9. This MOA shall be governed by and construed under the laws of the State of New York without giving effect to its principles of conflicts of laws. The parties also agree to submit to the jurisdiction of New York State Supreme Court in and for the County of Niagara for the purposes of adjudicating any dispute that may arise under this MOA.
- 10. The PBA agrees that upon execution of this MOA, it shall take steps to have the abovereferenced Proceeding dismissed with prejudice and shall prepare and have signed any and all necessary paperwork, including, but not limited to the stipulation of discontinuance attached hereto as Exhibit A.
- 11. The PBA agrees that upon execution of this MOA, it shall take steps to have the abovereferenced Mediation withdrawn.
