Approval of Change Order No. 2, Final Payment, and Project Acceptance

#### Honorable Body:

Approval of Change Order No. 2, approval of the final payment, and project acceptance of Phase VI of the Gratwick Riverside Park Marina is hereby requested.

Now that the marina project is complete, a review of the overall project is in order. Below is a table that summarizes the six (6) phases of construction over the past five years and the various funding sources utilized to complete the project.

As you can see, the City of North Tonawanda's total investment of \$1,555,475, representing 49.33% of total project cost, was utilized to secure \$1,598,044 in grant sources from Niagara County, New York State and the Federal Government respectively.

The city had a major liability as owner of the former vacant and dilapidated marina (Niagara River Yacht Club) before embarking on the new city marina project in 2012. In my opinion, the new marina is truly an asset to the city, where government funds were spent judiciously in creating a city marina that is equal to, or finer than others around the area.

As I indicated above, Phase VI of the marina construction was completed in two phases beginning in 2016 and completed in the Spring of 2017. The majority of the construction was completed in 2016 using city bonded funds with the installations of the docks, utilities, lighting, pathways and jet ski facilities.

On March 14, 2017, we met in a workshop to discuss utilizing the \$100,000 State Grant on the various marina park amenities. The following are the components that were added to the contract utilizing these funds to be approved by your honorable body as Change Order No. 2:

Accordingly, I respectfully request that the Common Council approve Change Order No. 2 for Phase VI of the Gratwick Riverside Park Marina 2016 Renovations Project to Pinto Construction Services, Inc., 1 Babcock Street, Buffalo, NY 14210, increasing the contract amount by \$83,140; from \$890,741.64, to the revised final contract amount of \$973,881.64; authorizing the Mayor to sign said change order, subject to review by the City Attorney. Further, the contractor has supplied the necessary form of guarantee; substantial completion; consent of surety; and affidavit for final payment so I also ask that the Common Council accept the project and approve final payment.
