XVII. Traffic Safety

Traffic Safety Minutes:

The February meeting of the North Tonawanda Traffic Safety Committee was called to order at 1900 hours. Roll call showed the following members present: J. Sikora, R. Frank, M. Anastasi, M. Daigler, and E. Smolinski. The minutes from the previous meeting were read and a motion to accept was carried. The following new requests/concerns were discussed and recommendations made.

- 1. The Committee discussed the changes made to the intersection of Payne Avenue and Fredericka Street as well as concerns from neighborhood residents. The Committee is comfortable with the removal of the traffic light as a four way signal and feels there is a learning curve with any change made to traffic flow. However the Committee is not against placing a detection device at the intersection that would allow the traffic signal to remain green for Payne Avenue until a vehicle approaches on Fredericka, tripping the detection device and stopping traffic on Payne Avenue with a red light allowing Fredericka Street traffic to proceed. Member Daigler has the ability to install the device. This would be a successful compromise for all residents in the area. Weather could factor into installation of the device.
- 2. Numerous complaints concerning employees of the bus garage on Plastics Drive parking on Euclid Avenue were discussed. This is an ongoing problem during the winter when plowed snow takes up parking places at the bus garage. Committee members Vater and Daigler spoke with bus garage supervisors on the issue. The area will be monitored for additional problems.
- 3. Parking around Drake School was discussed at the request of Jeff Gaston. The area will be monitored and discussed at the March meeting.

- 4. Signage warning of stop lines before the railroad tracks at the intersections of East Felton, Ward, and Witmer all at River Road were discussed. The Committee recommends making all signs the same making vehicles stop before the tracks.
- 5. Member Daigler reported on posting speed limit signs on Niagara Falls Blvd. NYS DOT was contacted and the signs will be addressed in the future.
- 6. Member Daigler reported he would like to see dotted lane markings placed at the intersection of TCMH and Tremont Street. These markings have worked well at the intersection of TCMH and Robinson. The Committee agrees with this and would like to see the markings placed when painting season begins.
- 7. Member Smolinski would like to see the grade near the railroad tracks at the intersection of Ward and River Roads addressed. There are makings on the road from vehicles scraping as they cross the tracks. Member Daigler will speak with Dale Marshall and Brad Rowles and report at the March meeting.

Meeting adjourned at 2025 hours.

My office has been informed that the Niagara Frontier Transportation Authority ("NFTA") is faced with a multi-million dollar deficit in the fiscal year beginning March 31, 2015. Attached is a resolution which outlines the current status of the NFTA, and the request for New York State officials to provide additional capital and operation assistance necessary to prevent further negative impacts on public transit and aviation services for the residents of the City of North Tonawanda and Western New York.

MOVED by Alderman Zadzilka SECONDED by Alderman Schwandt That the Common Council hereby approves the following resolution calling on New York State to Provide Needed Funding to the Niagara Frontier Transportation Authority ("NFTA").

WHEREAS, the Niagara Frontier Transportation Authority is the public transit and aviation service provider for the Buffalo Niagara region; and

WHEREAS, the NFTA provides over 30 million rides on public transit each year, supports close to 100 non-stop flights per day, employs 1,500 Western New Yorker's and provides transportation to and throughout the region for residents and tourists; and

WHEREAS, the public transit and aviation services provided by the NFTA enable Western New York's counties, cities, towns, and villages to achieve the mobility and quality of life goals and objectives collectively embraced and adopted in local and regional comprehensive plans; and

WHEREAS, the NFTA is faced with a multi-million dollar deficit in the fiscal year set to begin on March 31, 2015 and increasing deficits in future fiscal years because New York State public transit operating and capital assistance has not been provided at a level that is required to meet the public transit needs of Western New York's municipalities; and

WHEREAS, a 2013 financial assessment of the NFTA by the federal government concluded that the "NFTA has managed its operations efficiently and effectively, but has been hampered by zero growth in the revenue sources used to provide operating assistance;" and

WHEREAS, New York State public transit operating assistance to Downstate systems has increased over 8.5 percent since 2008 while the NFTA's state transit operating assistance has increased by only 2.5 percent over that same 6 year time period; and

WHEREAS, New York State public transit capital assistance is essential to the effective and efficient operation of the NFTA's public transit assets and frequently been budgeted for the NFTA, but not released; and

WHEREAS, the NFTA does not have taxing ability and therefore is reliant upon user fees and federal, state, and local operating and capital assistance to provide services; and

WHEREAS, additional New York State public transit operating and capital assistance is required to prevent further deterioration in the availability of public transit service that Western New Yorkers rely on to get to work, school or health care; and

NOW, THEREFORE, BE IT RESOLVED that the residents of the City of North Tonawanda relies on the public transit and aviation services provided by the NFTA to improve the economy and quality of life in Western New York; and

NOW, THEREFORE, BE IT RESOLVED that the City of North Tonawanda calls on New York State to provide the additional capital and operating assistance necessary to prevent further negative impacts on public transit and aviation services that are critical to the economy and quality of life in Western New York.

Stated that the property Mr. Krebs lives at or is the owner of was at one time zoned as a business and then it was abandoned and reverted back to the residential property. Stated it is a mess behind the property, a lot of abandoned tires and messy looking. Stated that because of the condition of the outside of his property, Mr. Krebs would not be an appropriate approval to the Environmental Committee because of how he keeps his property. The Mayor responded when he and the Common Council appoints someone to a committee, they go by their resume and credentials. They do not look at their home.
