WHEREAS, the North Tonawanda Common Council is in full support of the Carrousel Society of the Niagara Frontier's submission for assistance from the Consolidated Funding Application,

WHEREAS, as a requirement under the rules of these programs, said not-for-profit corporation must obtain the "approval/endorsement of the governing body of the municipality in which the project will be located",

WHEREAS, the requested funds would restore the original High Bay space, lost to the Allan Herschell complex almost 25 years ago. The restoration of this space to the complex will allow the Herschell Carrousel Factory Museum to interpret the bank organ heritage that is unique to North Tonawanda,

WHEREAS, in 2018, the Herschell Carrousel Factor Museum secured the necessary funding to complete the funding however, the pandemic arrived along with a moratorium on all construction grant projects. Meanwhile, fires in the western portion of the US have decimated much of our lumber forests. That and the increased demand have increased the price of wood

over 300 percent. Therefore, the cost of this project has increased from \$285,000 to \$395,000 and they need additional funding from Parks and Historic Preservation through the NYS Consolidated Application to complete the restoration,

WHEREAS, The Herschell Carrousel Factory Museum is a keystone for our emerging tourism industry in the Tonawandas and is highlighted on all welcome signs into North Tonawanda. Its visitors come from every state and numerous foreign countries. The interpretation of the band organ heritage will expand the visitor market in another dimension, bringing in even more visitors

WHEREAS, the City of North Tonawanda has a rich and proud history of many families with loved ones who have or are serving in the military. Many paid the ultimate sacrifice so we can live free. One only has to mention the Ganson Street Tigers during World War II, to realize entire neighborhoods went off to war for our nation and as a representation of the ultimate price they paid, we honor Marine Lance Corporal Timothy G. Serwinowski as this tribute to all who have paid the ultimate sacrifice: all gave some, some gave all.

WHEREAS, Lance Corporal Serwinowski, assigned to the 3rd Battalion, 6th Marine Regiment, 2nd Marine Division, died June 21, 2010 while supporting combat operations during Operation Enduring Freedom in Helmand Province Afghanistan. Helmand Province, a rural southern province, was considered a Taliban stronghold and was a major focus of US military offensive. He was only 21 years old when a sniper took his life.

WHEREAS, many of Tim's teachers at the North Tonawanda Senior High School described him as a quiet leader with a disarming sense of humor that made him a role model to his fellow students. It has been noted that many of his teachers would comment on his character and wished more kids were like Tim. As a senior, his football coaches honored him for his leadership and excellence after the team won the league's North Division Championship.

WHEREAS, Tim joined the Marines a year after high school and had been a Marine since 2008 and before his deployment, was stationed at Camp Lejeune North Carolina.

WHEREAS, Tim is survived by his mother Sally A. Urban, father Phillip A. Serwinowski, sisters Kate Brown (Serwinowski) and Emily Serwinowski. His parents are often at the Renaissance Bridge spanning the Tonawanda's every Memorial Day to help us to never forget.

NOW THEREFORE BE IT RESOLVED, that the City of North Tonawanda hereby renames a street the Tim Serwinowski Way as a reminder for all that freedom is not free.

NOW THEREFORE BE IT RESOLVED, that the City of North Tonawanda will create a policy that will set forth any future naming or renaming requests within the city limits.

To Whom it May Concern:

My name is Larry McKenzie, Chair of the 2021 Western NY Hydrocephalus Association (HA) WALK, scheduled for Saturday, September 11, 2021. We are a non-profit 501-C-3 group.

We are seeking permission to conduct a Chicken BBQ Drive-Thru dinner fundraiser at Gratwick Park. The date we are seeking is Saturday, July 24, 2021 beginning with setup around 7:00 am and with completion by around 7:00 pm. We are also considering having some form of entertainment as the cars drive thru. To help advertise the BBQ, we ask permission to put a sign at the entrance.

Hydrocephalus is caused by an excess accumulation of cerebral spinal fluid, placing the brain under pressure. There is no prevention – there is no cure. Current treatment methods may require patients endure multiple (sometimes dozens) of brain surgeries throughout their lifetime. Anyone, at any age, may be diagnosed with hydrocephalus. Unfortunately, head injuries to U.S. military personnel serving in Iraq and Afghanistan which resulted in hydrocephalus are dramatically increasing the numbers of Americans living with this challenging and complex condition.

The Hydrocephalus Association was founded in 1983 by parents of children with hydrocephalus who wanted to give everyone with hydrocephalus a better future – free of hydrocephalus constant life threatening complications. HA is dedicated to eliminating the challenges of Hydrocephalus. To achieve that HA added funding research to its portfolio of services just a few years ago – and is now the largest non-profit, non-governmental funder of hydrocephalus research in the world. The money raised with the Western NY HA WALK will be used to fund research and program services.
