The August 2021 meeting of the North Tonawanda Traffic Safety Committee was called to order at 1700 hours. Roll call showed the following members present: R. Frank, J. Sikora, M. Meisenburg, M. Daigler, M. Lemke, D. Grinnell, A. DiBernardo, M. Anastasi. The minutes from the previous meeting were read and accepted, the following new concerns/requests were discussed, and recommendations made.

- 1) Councilman Frank DiBernardo requested a "Children at Play" sign on Payne Avenue in front of Memorial Park due to lack of signage in a park area. Member Frank requested and was granted permission from Mayor Pappas to put up the proper signage. Member Meisenburg updated the proper signage in front of the park.
- 2) Janine Rizzo requested a "Children at Play" sign on Wheatfield Street in front of the Nation Little League Baseball Fields due to lack of signage in a ballpark area. Member Frank requested and was granted permission from Mayor Pappas to put up the proper signage. Member Meisenburg updated the proper signage in front of the baseball fields.
- 3) Gary Shaeffer of Wurlitzer Drive requested extra patrols for speeders on Wurlitzer Drive. Patrols made extra checks and the speed sign was placed there from 7/30/21 to present.
- 4) Suzanne Demonte requested signs at the bike path on Sweeney Street by the Service Drive Boat Launch. This appeared to be an oversight when the bike path was installed therefore member Meisenburg installed proper signage at the bike path that says "No Vehicles on the Bike Path".
- 5) Councilman Robert Schmigel requested that a RV be moved on 5th Avenue due to lack of sight for vehicles. Member Frank contacted the owner of the RV, Jeff Wagner, who moved the RV up the road to make a clear line of sight. Member Frank contacted City Attorney, Luke Brown, who advised the RV is legally parked long as it is not a traffic problem.
- 6) Justin Rich requested a stop sign at Wurlitzer Drive and Fairfax Avenue to slow down speeding. The committee checked on the request and found there is already a stop sign within 1 tenth of a mile on both sides of Fairfax. There was a prior traffic study done when Walmart was built which showed where the stop signs should be on Wurlitzer Drive. Fairfax was not one of the cross streets that needed a stop sign per the study. Member Frank posted the speed sign around different parts of

Wurlitzer Drive from 7/30/21 to the present day. Patrols will monitor the area. Member Frank advised Mr. Rich.

7) In July, Paul Schultz stated there were parking issues with a new vendor at the market. Schultz will be contacting the City Market Committee to try and resolve the problem. Member Frank will advise Donna Braun.

RESOLUTION ON COMMITTEE FORMED TO EXPLORE THE IMPACT OF NYS LEGALIZATION OF MARIJUANA By Collective North Tonawanda Common Council Robert E. Pecoraro, Frank DiBernardo, Eric Zadzilka, Austin Tylec, Robert Schmigel

WHEREAS, on March 31, 2021 Governor Andrew M. Cuomo signed the Marijuana Regulation & Taxation Act (MRTA) which legalized the recreational adult-use of cannabis for individuals 21 years of age or older in the State of New York; and

WHEREAS, municipalities have the ability to remain in or opt-out of allowing adult-use cannabis retail dispensaries or on-site consumption licenses to operating within their jurisdictions within accordance to MRTA and the Cannabis Control Board; and

WHEREAS, if municipalities wish to opt-out, said municipality must pass a law by December 315 2021 or nine months after the effective date of the legislation detailing such ordinances and is subject to a permissive referendum as outlined in section twenty-four of the Municipal Home Rule Law; and

WHEREAS, we the North Tonawanda Common Council request that Mayor Arthur G. Pappas creates a committee to examine the potential ramifications of both remaining in or opting-out of allowing adult-use cannabis retail dispensaries or on-site consumption licenses within the city limits; and

WHEREAS, such a committee be created by the Mayor with the goal of getting input from our residents on this important and new legislation passed by the State of New York; and

WHEREAS, this committee be compromised of a diverse group of city residents and community leaders in order to obtain an objective and fair assessment of the impacts of MRTA; and

WHEREAS, this committee should examine and explore the impacts of such ordinances in the fields of public safety, public health, and financial revenues/burdens; and

WHEREAS, this committee must issue its recommendation to the Common Council by November 29, 2021 to allow the Common Council to pass the necessary legislation prior to December 31,2021; and

NOW, THEREFORE, BE IT RESOLVED that Mayor Arthur G, Pappas forms a committee to examines the issues mentioned in this resolution above and makes issues its recommendation to the North Tonawanda Common Council by November 29, 2021.
