



As part of the city's commitment as a member of the Western New York Stormwater Coalition beginning in 2010, the city has implemented a stormwater program to bring the city in compliance with the stormwater regulations and requirements of the Federal and State Government with the assistance of JM Davidson Engineering D.P.C.

The tasks of the consultant are to attend WNYSC Meetings, to prepare the annual stormwater report for submission to NYSDEC, to inspect and report on all City storm water detention facilities and stormwater management units, to assist the DPW in the annual inspection of the City's storm sewer outfalls to the Niagara River, and Tonawanda and Sawyer Creeks respectively, and to assist the City with SWPPP reviews and inspections. JM Davidson Engineering, D.P.C. (JMD) appreciates the opportunity to submit the following proposal to continue assisting the City of North Tonawanda (City) with implementation of your Stormwater Program. The City has a well-defined Stormwater Management Program (SWMP) that maintains compliance with the requirements of the previous NYSDEC SPDES General Permit (GP-0-15-003); however, a new permit went into effect on January 3, 2024 (GP-0-24-001) that has new requirements and associated time frames that the City must comply with. This proposal has been developed to assist the City with completing the items required by NYSDEC in 2024.

#### SCOPE OF WORK

The scope of services and basis of contract shall be as follows, including the assumptions made in developing the scope of work.

#### Task 1 – Attend WNSYC Meetings

1.1 JMD will continue to attend the Western New York Stormwater Coalition (WNYSC) meetings (assumed 5 meetings throughout the year) on behalf of the City. JMD is currently representing the City on the WNYSC Executive Board.

#### Task 2 - Interim Progress Certification

- 2.1 One of the new requirements of GP-0-24-001 is the submission of an Interim Progress Certification by October 1, to document the work performed by the City from January 3 through June 30. The format of the Interim Progress Certification and information required to be submitted is still unknown; however, we do expect it to be done electronically in the NYSDEC NForm system. We have included time for the following:
  - a. Meeting with City Department Heads, as needed, to gather information required for the Interim Progress Certification.
  - b. Preparing the Interim Progress Certification electronically for review by the City.
  - c. Incorporating review comments, finalizing and submitting the Interim Progress Certification on behalf of the City. Alternately, the City Engineer may elect to directly submit this report before the October 1 deadline.

#### Task 3 – Complete Revision of SWMP Plan and Draft Enforcement Response Plan (ERP)

- 3.1 The City's existing SWMP Plan was originally developed from the WNYSC model SWMP plan in 2010 and is in need of a complete revision to meet the new requirements of GP-0-24-001. A thorough update of all sections, lists, tables, contacts, appendices, etc. will be conducted. Additionally, the plan will be reformatted to be navigated easily and provide clearer direction as to responsible parties and timelines.
- 3.2 JMD will draft an ERP template and work with the City Engineer and City Attorney to ensure that is it consistent with existing City codes and reflects the procedures desired by the City. The ERP is required as part of the new SWMP.
- 3.3 JMD will meet with the City Engineer to review the draft SWMP Plan prior to completion of the final document.
- 3.4 JMD will coordinate with the City to post the final SWMP Plan on the City's Stormwater webpage for public review and comment.

#### Task 4 – MCM 1/2: Public Education and Outreach

- 4.1 Review the City's existing public outreach program including placement of posters/flyers/brochures, City's stormwater webpage, and public education events. Coordinate with the SMO regarding updates to the Public Education and Outreach plan to incorporate into the SWMP plan.
- 4.2 JMD will develop posters on the following topics that can be used to train municipal staff and be hung in municipal facilities as a reminder to staff of the stormwater requirements:
  - a. Illicit Discharge Detection and Elimination
  - b. Pullution Prevention and Good Housekeeping

#### Task 5 – MCM 3: Illicit Discharge Detection and Elimination (IDDE)

- 5.1 Conduct outfall inspections on behalf of the City. Assume up to two days in the field for a team of three. JMD will use Jotform to document the outfall inspections and copies of the inspection reports will be provided to the City upon completion.
- 5.2 JMD will assist the City Engineer in following up with Confer Plastics, which was the subject of IDDErelated complaints in previous years. JMD has budgeted one day for a team of two to coordinate and complete a site visit to Confer Plastics and Gratwick Park.

#### Task 6 - MCM 4: Construction Site Runoff

6.1 Assist the City with construction site SWPPP compliance inspections and/or SWPPP review as necessary. We have budgeted up to 48 hours for this task.

#### Task 7 – MCM 5: Post-Construction Stormwater Management

- 7.1 Develop an updated inspection form in Jotform and standard inspection procedures, which will be incorporated in the SWMP Plan.
- 7.2 Conduct inspections of the City-owned and operated above ground stormwater management facilities (no hydrodynamic separators will be inspected). If the DPW is planning to inspect/clean the filter units on Meadow Drive, the timing can be coordinated with the other inspections, and proper traffic control is established in the roadway, JMD can assist with an inspection of the filter units. We

have budgeted one day for a team of two to assist the City with stormwater management practice inspections.

7.3 Provide a technical memorandum to the City that summarizes the inspection reports and maintenance recommendations to the City.

#### Task 8 – MCM 6: Pollution Prevention / Good Housekeeping (P2/GH)

- 8.1 Conduct P2/GH inspections of additional City facilities not inspected in 2023. We have budgeted for two days of field inspections and will coordinate with the City Engineer on which sites to include and scheduling the inspections.
- 8.2 Reach out to the facilities inspected in 2023 to determine if recommendations have been implemented or if additional work is required. Our findings will be documented and sent to the City Engineer for additional follow-up.
- 8.3 Meet with DPW to conduct self-audits on municipal processes, such as road salting and street sweeping.
- 8.4 Provide training in an informal setting (tailgate-type training) for the following municipal staff: Golf Course Maintenance, Parks Maintenance Garage, City Hall Building Maintenance. It is assumed that the posters developed under Task 4 will be utilized as the base presentation material.

#### **FEES AND TERMS**

Services described above shall be provided on a Time and Expense basis with a fee not-to-exceed **\$50,000**. Our fee is based on the projected hours, rates, and expenses detailed in **Table 1** on the following page.







# **Price Proposal**

Hazen is pleased to submit our fee proposal, which includes a breakdown of engineering fees for each task, showing personnel hours, subcontractor costs, and reimbursable expenses, consistent with the RFP requirements and our proposed approach. We also indicate the percentage of the Opinion of Probable Construction Cost (OPCC) and the average hourly billing rate for each phase of work.

Please note that the Resident Project Representative services (Task 4) is based on a combination of part-time inspection (20 hours per week) and full-time inspection (40 hours per week) over an 18 month construction schedule. We have assumed the initial three months and final three months of construction would be part-time inspection while the middle twelve months of construction would require full-time inspection, totaling 2,600 hours. In addition, Hazen has included 300 hours to provide additional construction support throughout the project and specifically during major shutdowns, tie-ins and interconnections, to ensure that this work is completed within the allowable shutdown window while minimizing any impact on plant operations.

Though the RFP requests a lump sum bid, we recommend that RPR services be invoiced on an hourly basis. We believe our RPR fee estimate is conservative and expect to remain under this amount so that any unused fee remains with the City.

#### Fee Review and Negotiation

We believe our approach and fee structure will provide the City with the high value that you expect and deserve. Our project team, combined with our more than 1,700+ nationwide professionals who are solely focused on 'all things water,' are excited about this opportunity to demonstrate our value. If you have any questions regarding the information we have presented, we welcome the opportunity to further discuss and/or review and refine our proposed scope and fee to meet the City's needs.

Empire State Development recently announced Round 8 of the Restore NY Communities Initiative grant with the purpose of "providing municipalities with financial assistance for revitalization of commercial and residential properties. The program encourages community development and neighborhood growth through the elimination and redevelopment of blighted structures."

Municipalities may apply for up to \$2 Million and eligible projects must "demolish, deconstruct, rehabilitate and/or reconstruct vacant, abandoned, condemned and surplus properties." Successful applications should demonstrate as many of the following as possible: project feasibility, project readiness, location within an urban downtown, location within a Brownfield Opportunity Area, consistent with community redevelopment plan, ability to induce commercial investment, and clearly identified need.

Given the criteria noted above, with a particular emphasis from Empire State Development on project feasibility and project readiness, the Department of Community Development believes that the 235 River Road Mixed-use redevelopment project, led by 235 River Rd. LLC/Alliance Homes would make a strong application.

235 River Road (and 190 Main Street) is currently a 3.1 acre blighted property along a key gateway point connecting Downtown to the Niagara River waterfront. Redevelopment of this property has been identified as a key revitalization opportunity in the NT Momentum Plan.

With assistance from the Restore NY program, this would aid in the demolition and reconstruction of the property to include a mixed-use and commercial development project consisting of a four-story building with 40 market rate apartments, and a four story/one story

building with 32 apartments, 9,400 SF of commercial space, clubhouse/amenity space, 166 parking spaces, landscaping, lighting and utility improvements.

The Department of Community Development held a required public hearing for this application on May 14<sup>th</sup>, 2024 and has met the requirements for publishing the Property Assessment List in the Niagara Gazette.

I kindly request your authorization for the attached Municipal Resolution, and for the Mayor to sign and submit a grant application for approximately \$2,000,000 to Empire State Development under the Round 8- Restore NY Communities Initiative, which is due on May 22<sup>nd</sup>, 2024.


