SHARED SERVICE AGREEMENT

THE CITY OF NORTH TONAWANDA AND THE NORTH TONAWANDA SCHOOL DISTRICT

This Shared Service Agreement ("Agreement") is entered into as of [DATE], by and between the City of North Tonawanda ("City"), a municipal corporation located in the County of Niagara, State of New York, and the North Tonawanda School District ("School District"), a public school district organized and existing under the laws of the State of New York.

WHEREAS, the School District currently contracts with private companies for underground water, sewer, and sanitary emergency repairs, which can result in delays, increased costs, and oversight by the City; and

WHEREAS, the City Water Distribution Department possesses the expertise, equipment, and personnel necessary to provide such services efficiently; and

WHEREAS, both parties recognize the benefits of cooperation and shared services in order to improve efficiency, reduce costs, and provide timely emergency repairs; and

WHEREAS, the City Department of Public Works (DPW) has the capability to assist with backfilling, paving, and patching of repair sites; and

WHEREAS, both parties are authorized under New York State law to enter into shared service agreements to enhance public services and operational efficiencies.

NOW, THEREFORE, in consideration of the mutual promises and agreements set forth herein, the City and the School District agree as follows:

1. Scope of Services

- 1.1 The City Water Distribution Department may, at its discretion and subject to availability, provide assistance to the School District for emergency underground water, sewer, and sanitary repairs.
- 1.2 The City Department of Public Works may, at its discretion and subject to availability, assist with backfilling, paving, and patching of repair sites.
- 1.3 The City shall not be obligated to perform services under this Agreement if such services would interfere with the City's primary responsibilities or other pressing municipal needs.
- 1.4 Any non-emergency repairs or planned maintenance requests shall be reviewed and approved by the City before any work begins. 1.5 The School District shall provide the City with timely notification of any repair needs and cooperate fully to facilitate efficient service delivery.

2. Cost and Payment

2.1 The School District agrees to reimburse the City for all costs incurred, including but not limited to labor, materials, equipment usage, and administrative expenses. 2.2 The City shall provide an itemized invoice to the School District detailing the time, materials, and costs associated with each service provided. 2.3 Payment shall be made by the School District to the City within thirty (30) days of receipt of the invoice. 2.4 The City reserves the right to adjust service rates annually based on labor, material, and equipment cost fluctuations.

3. Liability and Indemnification

3.1 The School District agrees to indemnify, defend, and hold harmless the City, its officers, employees, agents, and representatives from and against any and all claims, damages, liabilities, losses, costs, and expenses (including reasonable attorney fees) arising from the City's performance of services under this Agreement, except where such claims arise from the gross negligence or willful misconduct of the City. 3.2 The City agrees to indemnify, defend, and hold harmless the School District, its officers, employees, agents, and representatives from and against any and all claims, damages, liabilities, losses, costs, and expenses (including reasonable attorney fees) arising from the City's gross negligence or willful misconduct in providing services under this Agreement. 3.3 Both parties shall maintain adequate insurance coverage, including general liability and workers' compensation insurance, as required by New York State law. 3.4 Each party shall promptly notify the other of any claims, actions, or proceedings arising from activities conducted under this Agreement.

4. Term and Termination

4.1 This Agreement shall commence on [START DATE] and remain in effect for a period of [TERM LENGTH, e.g., one year] unless terminated earlier by either party. 4.2 Either party may terminate this Agreement upon thirty (30) days' written notice to the other party. 4.3 In the event of termination, the School District shall be responsible for paying any outstanding invoices for services rendered prior to termination. 4.4 The City and School District may review and amend this Agreement annually to address any operational changes or financial considerations.

5. Reporting and Oversight

5.1 Both parties shall designate a point of contact to oversee the implementation of this Agreement and facilitate communication. 5.2 The City shall maintain records of all services performed under this Agreement and provide periodic reports to the School District upon request. 5.3 The School District shall keep records of service requests and any necessary permits related to repairs.

6. Miscellaneous

6.1 This Agreement constitutes the entire understanding between the parties and supersedes any prior agreements, whether written or oral. 6.2 No modification or amendment of this Agreement shall be valid unless in writing and signed by both parties. 6.3 This Agreement shall be governed by and construed in accordance with the laws of the State of New York. 6.4 If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect. 6.5 This Agreement shall not be assigned by either party without the prior written consent of the other party. 6.6 Any disputes arising under this Agreement shall first be addressed through negotiation between the designated points of contact. If resolution cannot be reached, the matter may be referred to mediation or legal proceedings as necessary.

LICENSE AGREEMENT

THIS AGREEMENT, made this 20th day of May, 2025, by and between the CITY OF NORTH TONAWANDA, NEW YORK, a municipal corporation organized under the laws of the State Of New York with an office at 216 Payne Avenue, North Tonawanda, New York 14120 (hereinafter "City") and the IMAGINE COMMUNITY GARDENS, INC. a New York Not-for-Profit Charitable Corporation with an office at 7071 Transit Road, Amherst, NY 14051 (hereinafter "ICG").

WITNESSETH:

WHEREAS, the City is currently the owner of certain vacant land located at 228 Sommer Street, North Tonawanda, New York 14120 as depicted in the Exhibit "A" attached hereto and made a part hereof, and

WHEREAS, the ICG wishes to use said vacant land and make improvements for a community garden for use by the general public.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. LICENSE. City hereby grants and conveys to ICG the right, permission, privilege and authority to install and maintain a community garden at 228 Summer Street, North Tonawanda, New York 14120 together with the right of ingress and egress to and over the above described premises, as well as the right of ICG to do all other acts and things requisite or necessary to fulfill the purpose of a community garden. This license is conditioned upon the City's receipt and approval of a description of the work to be done. The license granted involves the property described in the attached maps incorporated herein as **Schedule "A"**. City covenants to ICG that: (1) it is the owner of the above described land and it has full right and authority to grant the license described herein; (2) ICG may quietly enjoy the premises for the purpose herein stated; and (3) the City will not create or permit any obstruction of any kind or character that will interfere with the use for the purpose stated herein.
- 2. TERM. That the term of this Agreement shall be for a term of five (5) years effective June 1, 2025 and ending May 31, 2030. This Agreement may be terminated by the CITY upon six (6) months' written notice to ICG at the address of its duly authorized representative to receive said notice. This representative's name, address and phone number will be available to the City Clerk, and any changes in same will be provided upon request and also as said change occurs.
- 3. RENT. The rental for this period shall be paid in-kind by the ICG with the improvements made over the course of the term of this Agreement.
- 4. IMPROVEMENTS/REPAIRS. The ICG agrees to supply the City all material necessary to connect to the public water main including but not limited to copper pipe, backflow preventer, shut off values and fittings. The City agrees to provide the necessary labor to cut the

road, if necessary, and dig up the land to install and connect water service to 228 Sommer Street, North Tonawanda, New York 14120. ICG shall plant and water all vegetables and install trellises, benches, fencing, and signs. In the event that the City exercises its option to terminate the License the ICG shall be permitted to remove all improvements that are removable and to restore the land to the condition in which it received the land. The ICG further agrees to be responsible for any maintenance and upkeep required for any equipment which it may install or erect upon the premises. The City will provide City water at no cost, however, the City, in its absolute discretion, may charge for water consumption at any time, upon 5 days notice, at any point during the term of this Agreement.

5. MECHANIC'S LIENS. ICG shall keep the Property free and discharged of mechanic's and materialmen's liens and encumbrances affecting the licensed interest created hereby which are the results of ICG's acts or omissions. The breach of this covenant by operation of law or for any other reason, even if affecting only a portion of the Property, if not promptly cured, will entitle City, at its option, to terminate and cancel the License.

ICG agrees, within thirty (30) days after the filing thereof (or such shorter period as may be required in order to protect City's interest in the property) to discharge (either by payment or by filing the necessary bond or otherwise) any mechanic's, materialmen's or other lien against the Property and/or City's interest herein, which liens may arise out of any payment due for, or purported to be due for any labor, services, materials, supplies or equipment alleged to have been furnished to or for the ICG in, upon or about the Property. Any period of time shorter than thirty (30) days after the filing of the lien must be a reasonable request by the City.

- 6. INSURANCE. ICG agrees to carry all necessary insurance that may be required by the City and to name the City as additional insured and hold the City harmless from any and all claims arising out of the operation of the community garden. The following insurances are required at a minimum. The ICG agrees, at its own expense, to provide during the duration of this agreement, the following insurances:
 - A. General Liability Insurance for bodily injury and death, with the City, its agents, officers and employees, as additional named insureds with limits of not less than \$1,000,000 per occurrence and \$3,000,000 in the aggregate.
 - B. Certificates of the required insurance shall be submitted to the City Attorney's Office for review and approval at least sixty (60) days prior to the start of the event.
- 7. INDEMNIFICATION. The ICG agrees to defend and indemnify the City, its officers, agents and employees, and shall hold them harmless from any and all risks of every kind, nature and description resulting from or arising out of the work and/or service performed by the ICG, or its subcontractor, under this contract; provided, however, that the ICG shall not be required to indemnify the City with respect to such risks to the extent caused by the negligence or intentional misconduct of the City or the City's contractors, over whom the ICG has no authority or control.

The ICG by agreeing to defend the City as set forth above, agrees that if the City receives a claim, complaint, or is sued under this contract pertaining to their work, acts or services; then





Project Background

The Downtown Revitalization Initiative (DRI) Oliver Street Walkability & Implementation of Smart Growth Project ("Oliver Street DRI Project") has been deemed a Type II Action under SEQRA by the City of North Tonawanda, the lead agency. The project meets the criteria of 6 NYCRR Part 617.5(c)(3) "retrofit of an existing structure and its appurtenant areas to incorporate green infrastructure." The associated project scope includes modifications to the existing Oliver Street corridor to implement green infrastructure practices and perform improvements to the cityscape for pedestrians. The pedestrian improvements meet the criteria of 6 NYCRR Part 617.5(c)(2) "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building, energy, or fire codes unless such action meets or exceeds any of the thresholds in Section 17.4 of this Part.".

More specifically, the Oliver Street DRI Project includes: sidewalk improvements, conversion of impervious areas to green spaces, curb bump outs for tree plantings and bioretention areas that will also improve pedestrian safety, tree plantings, installation of structural soils and stormwater planters, extending an existing storm drain line, and separation of a portion of combined sewer at the northern end of the project area, lighting improvements, and accessory improvements including benches, bus shelters, and decorative pavements.

This document provides additional information related to the environmental review questions for the Oliver Street DRI Short Environmental Assessment Form (SEAF). Questions that were not able to be answered fully in the form are further discussed here to demonstrate that a thorough assessment of the environmental resources found within the project area and the potential impacts on these resources was conducted.

As a Type II Action, this project will not have a negative impact on the environment. No further review under SEQRA is required.

Question 4 – Land Use Near Proposed Action

Oliver Street is within a residential suburb with scattered industrial and residential uses, and commercial businesses. The industrial uses found in the project area include a recycling facility, a tire center, and a specialty contractor offering glass, metal, aluminum, stainless steel, and composite panel services. Commercial businesses along Oliver Street include the U.S. Postal Service, Railroad Museum of the Niagara Frontier, auto body shops, convenience stores, and other commercial goods and service businesses. The Erie Canal is located at the southern most extent of Oliver St and at the intersection with Sweeney Street. Heritage Park located in the northern portion of the project area on the east side of Oliver Street, north of the intersection with E Oliver Street and south of the intersection with Thompson Street (See attached Figure 1 Project Location Map in **Attachment A**).

Question 5 – Zoning Regulations and Comprehensive Plan

The portion of Oliver Street between the intersections with Sweeney Street north to Thompson Street, is zoned as "C2 General Commercial". Any use is permitted in this district with stipulations to preserve the visual aesthetics and general enjoyment of the public in the area. The Comprehensive Plan emphasizes the need to enhance the aesthetic and visual character of the City while promoting pedestrian activity. The project is also a part of the City of North Tonawanda's Downtown Revitalization Initiative to increase walkability and enhance streetscapes. The City also has goals to reduce the amount of combined sewer systems and improve water quality throughout the city. This project is consistent with all of these overarching goals.

Question 6- Consistency with the Predominant Character of the Area

The Oliver Street corridor contains a variety of commercial businesses and noteworthy places in the city. These places rely on the public to visit these places. The DRI project is consistent with the predominant

character of the area by enhancing the appeal of the corridor to the public. The corridor is connected to the waterfront of the Erie Canal where pedestrian traffic is congregated. Increasing the aesthetics and safety for pedestrians will in turn increase pedestrian traffic to existing commercial businesses along the corridor and to the landmarks such as Heritage Park and the Railroad Museum.

Question 8 – Public Transportation and Pedestrian Accommodations

The project proposes sidewalk improvements along the corridor which will improve the walkability of this portion of the City. Additionally, the proposed bumpouts, street markings, crosswalks, access ramps, and detectable warning pavers will all improve pedestrian safety along the Oliver Street corridor.

This section of Oliver Street is also served by the Niagara Frontier Transit Agency (NFTA) bus route #25. The project includes accommodation for bus patrons with additional bus shelters at select bus stop locations.

Question 11 - Wastewater Treatment

The project is located in a combined sewer area within the City of North Tonawanda. As part of this project, the City proposes to extend an existing dedicated storm drain line to the northern end of the project area and separate approximately 1,500 LF of roadway storm drain system from the combined sewer system. This will aid in reducing the amount of inflow and infiltration (I&I) from the sanitary system and reduce the wastewater treatment requirements from the City's wastewater treatment plant.

Question 12 - Cultural Resources

The project area is located near the New York State Barge Canal Historic District and the Sweeney Estate Historic District. Additionally, there are multiple structures that are either listed or eligible for listing on the State and National Register of Historic Places within the corridor.

A description of the project along with information about several properties within the corridor was submitted to the Office of Parks, Recreation, and Historic Preservation State Historic Preservation Office (SHPO) via Cultural Resources Information System (CRIS) (Consultation No. 25PF01741). SHPO reviewed the project scope and the cultural resources within the corridor. In a letter dated April 9, 2025, SHPO determined that the project would have No Adverse Impact on historic or archeological resources. The letter is provided in **Attachment A.**

Question 13 - Water Resources

There are no wetland or surface waterbodies within the project corridor; however, the City of North Tonawanda's "Town Ditch" runs across Oliver Street and is identified on the NYSDEC Environmental Resource Mapper as a Class C waterbody. The Town Ditch is an abandoned subsurface tunnel beneath the streets that was historically used for drainage conveyance when the Canal was operational. The Ditch was abandoned around 1920 and bulkheaded off in multiple locations. The structure no longer conveys flow and is therefore not a stream channel and not subject to permitting or protection.

Question 17 – Stormwater

The project will effect the City of North Tonawanda's MS4 system. The project includes extending an existing storm drain system to separate approximately 1,500 LF of roadway within the combined sewer system.

The project also includes the construction of water quality treatment facilities including: bioretention areas, green space areas, structural soils, planters, and tree plantings. These facilities will provide some water quality treatment throughout the project corridor and help to reduce peak flow during regular storm events.

Oliver Street DRI Project SEQR SEAF Supplemental Information

Due to the size of the project, coverage under SPDES General Permit 0-25-001 for Storwmater Discharges from Construction Activities will be required. A Stormwater Pollution Prevention Plan (SWPPP) will be prepared for the project. The storm system in this area is owned by the City of North Tonawanda and within their MS4 district, as such the City will be responsible for reviewing and approving the project and SWPPP.

Question 20 – Subject of Remediation for Hazardous Waste

The Former Remington Rand Facility Site, known as Remington Lofts on the Canal, LLC today, is located roughly 100-ft west of Oliver Street, separated by railroad tracks. This building was an element of the remedial program under NYS Brownfield Cleanup Program (BCP), administered by New York State Department of Environmental Conservation (NYSDEC) in accordance with the Brownfield Cleanup Agreement (BCA) (September 2010)¹. This project, however, has no direct impact on the Oliver Street DRI Project.



Thank you for requesting the comments of the Division for Historic Preservation of the Office of Parks, Recreation and Historic Preservation (OPRHP). We have reviewed the submitted materials in accordance with the New York State Historic Preservation Act of 1980 (Section 14.09 of the New York State Parks, Recreation and Historic Preservation Law). These comments are those of the Division for Historic Preservation and relate only to Historic/Cultural resources. They do not include potential environmental impacts to New York State Parkland that may be involved in or near your project.

The proposed project area is adjacent to the US Post Office – North Tonawanda, which is listed in the State and National Registers of Historic Places. It is also adjacent to the Railroad Signal Tower (152 Oliver Street), Rainbow Rink and Carousel Apartments, which are eligible for listing. Our office has reviewed the proposed Oliver Street walkability project. We note that work is proposed within the existing right of way and that no physical work on the above-mentioned historic resources is proposed. Based upon our review, it is the OPRHP's opinion that this project will have No Adverse Impact on historic or archaeological resources.

Traffic Safety Minutes:

The April meeting of the North Tonawanda Traffic Safety Committee was called to order at 1800 hours. Roll call showed the following members present: M. Meisenburg, R. Frank, N. Ferguson, M. Nalbone, N. Phelps and R. Brennan. The minutes from the previous meeting were read and accepted, the following new concerns/requests were discussed, and recommendations made.

- 1. Carlton Durham from 1416 East Robinson Rd requested the right lane coming from the boulevard on the bridge going west bound on East Robinson be changed to right turn only. The reasoning is that on Robinson bridge there are two lanes and as you cross over Sweeney St. there is one lane. So, people tend to race side by side to get over in one lane. As they do this, the cars come so close to the mailboxes and often knock them over. People are concerned about getting their mail because they don't want to get hit. The committee will continue to monitor this area to make a final decision.
- 2. Member Frank will be setting up the speed sign on Doebler. There were concerns of frequent vehicles speeding near 1292 Doebler.
- 3. Member Brennan had a request on Walck Rd going West bound at Nash Rd that the right lane should be right turn only. The reasoning is two lanes turn into one lane and drivers like to race to get ahead of each other before it turns into one lane as they drive through the intersection. The committee will continue to monitor this area to make a final decision.
- 4. After Multiple accidents on Payne Ave at the curve between Fredericka St. and Jackson the council is in favor of putting a guard rail along the curve. The pedestrian traffic is very high on that curve and the committee would hate to see any more injuries. As the chairman of the committee, I am looking into getting a quote on guard rail material. The DPW will be installing saving on labor costs.
