Below for your consideration, is a proposed revision, under North Tonawanda City Code § 51 D (3) – Registration of Rental Units.

§ 51 D (3) – Registration of Rental Units:

"<u>All</u> Owners and lessors, or their respective agents, of rental housing units or multiple dwellings within the City of North Tonawanda who do not reside or maintain a principal place of business within Niagara County, New York, or an adjoining County of Niagara County, New York, shall within two months after the effective date of this provision, or within 30 days from the date of mailing forms by the Code Enforcement Officer, whichever occurs first, register with the building department each rental housing unit or multiple dwelling they own or operate in the City of North Tonawanda. The following information shall be provided:

If your Honorable body concurs, please pass the appropriate resolutions for the City of North Tonawanda to allow these additions to our North Tonawanda City Code, subject to further review by the City Attorney.


