**RULES AND REGULATIONS**

1. Permit is only good for 1 year (April 1 to March 31) for the year or for the partial year (April 1 to September 30 and October 1 to March 31) that the applicant applies as noted above. The initial application cost is \$400 for full year, \$275 for half year and a daily rate of \$35. Failure to renew each year will result in removal from permit list as well as a renewal requirement of the original fee.
2. The undersigned agrees that he/she will comply with the Rules and Regulations of the City of North Tonawanda Farmers' Market pursuant to Chapter 71 of the North Tonawanda City Code and all other Rules/Regulations set forth by the Market Clerk. Non-compliance with market rules will result in cancellation of market agreement with vendor and removal of undersigned from the market venue with no refund of market fees.
3. The undersigned further certifies that he/she is the responsible person and he/she is authorized to (1) Execute on behalf of the above company and (2) Accept legal process on behalf of the above business.

4. The undersigned also agrees to indemnify and hold harmless the City of North Tonawanda Farmers' Market, City of North Tonawanda, and the City Market Clerk from and against any and all liability, damage, expense, cause of action, suits, claims, penalties and/or judgments arising from injury to person sustained by anyone as a result of consuming any food or drink acquired from me, use of any item purchased from me, or from any negligent action on my part.
5. Vendor is responsible for all monies collected from the sale of Vendor's goods. The City of North Tonawanda Farmers' Market, City of North Tonawanda, and City Market Clerk are in no way responsible for any lost or stolen monies or items.
6. Insurance Requirements: All vendor's must provide the following proof of insurance requirements and **name the City as both the Certificate Holder and must name the City of North Tonawanda as additionally insured.**
  - a. General Liability: The policy will include coverage for bodily injury, property damage, personal injury, advertising injury, contractual liability, products/completed operations. This insurance will be primary and non-contributory.
    - i. Per Occurrence Limit: \$1,000,000.00
  - b. Automotive Liability: The policy will include coverage for all vehicles owned, hired, non-hired, non-owned and borrowed by the Consultant in the performance of the Services covered by this Agreement. This coverage will be primary.
    - i. Limit: Per state requirement, if any
