Dear Honorable Mayor Pappas and Common Council:

Recently the Building Department has brought to my attention a concern of illegal chicken coops and cages throughout the City of North Tonawanda. Section 57 of the North Tonawanda City Code - Livestock, lays out how to properly go about receiving a permit for a Chicken Coop. This section also lays out the penalties for not getting the proper paperwork.

Due to the concern from citizens and the Building Department I recommend changing the penalty of this section of the code if the procedures are not followed. Currently the code reads as follows:

§57-8. Penalties

Any person, firm or corporation violating any provisions of this ordinance shall be guilty of an offense and, upon conviction, be punished by a fine of not more than \$50 or by imprisonment for not more than six months, or by both.

I recommend the following changes:

§57-8. Penalties

Any person, firm or corporation violating any provisions of this ordinance shall be guilty of an offense and, upon conviction, be punished by a fine of not more than \$50 per day for each offense or by imprisonment for not more than six months, or by both.

Re: City Code Chapter 25 Building Permits §25-8 Late filings; failure to schedule inspections; penalties for offenses (A.)

Honorable Body:

I would like to recommend the following changes to Chapter 25 Section 8 of the City Code of North Tonawanda. These changes will allow easier enforcement of Building, Electrical, Plumbing and Engineering permit violations by making the language more comprehensive. Permits are required for more than just structures. In its present form it limits our enforcement opportunities. The proposed Code change reads as follows:

§25-8 Late filing; failure to schedule inspections; penalties for offenses

 $\underline{\mathbf{A}}$.

Any person who shall commence work on any construction, demolition, alteration, removal or any activity requiring a permit from the Building or Engineering Department without first obtaining the required permit shall be required to pay as a penalty, a fee of twice the amount of the regular fee when making late application for such permit. Whenever any person shall commence such construction without having first obtained a permit, the Building Inspector shall stop all construction. Anyone failing to obtain a permit within one business day after a stop-work order has been issued shall be subject to a fine not to exceed \$250 in addition to payment of the double fee for such late filing.

Re: Zombie Property Prevention / Remediation Services Proposal

Honorable Body:

In November 2017, the City entered into a one-year contract with the Western New York Law Center (WNYLC) to assist with the implementation of a Zombie Property Remediation program under a grant program funded by the Local Initiative Support Coalition (LISC) Zombie Property Prevention grant.

To date, WNYLC has completed the research, outreach, and training portions of the grant scope of work. See the attached summary page for a listing of project accomplishments. These services have been billed at \$18,055.95.

To complete the remaining deliverables of the LISC grant, I would like to hereby request the Council authorize an extension of the contract with the WNYLC through April 30, 2019. Expected deliverables are attached as well and include: continued outreach to homeowners facing foreclosures, hosting at least 2 more outreach / training public events, closer work with NT Code Enforcement to pursue banks holding zombie properties, research and policy preparation in consideration of a vacant property registry, and research and policy guidance for consideration of participation in the NY Assistance Program for city residents.

WNYLC has proposed a fee of \$26,740.00 to provide these services to the City. This fee will be covered out of the remaining LISC grant funds with no direct cost to the City. I hereby respectfully request the Common Council authorize the Mayor to extend the contract with Western New York Law Center, Inc., pending review and approval by the City Attorney, for Foreclosure Prevention / Remediation assistance at the proposed fee of \$26,740.00.
